(Registration period: 03/09/2021 to 09/09/2022)

#### Don't Miss Your Chance!

- Copy of Birth Certificate
- Copy of Passport
- Venezuelan National Identification Copy (ID)
- Four (4) Passport-Style
- Money order for \$545 in name of: U.S Department Of Homeland Security (Under 14 years old must pay \$50 and Mayores 65 years \$135)
- Police record of counties where you have resided for more than six (6) months, in case you have arrests you need a copy of the arrests and provisions
- Proof of continuous physical presence from March 8, 2021: (employment registration, rental receipts, invoice (light, water, internet, cable etc.) School records in the United States, hospital records or medical records, copy of taxes church returns, or other organization that knows you, etc.
