President Biden's plan, announced in June, aimed to benefit approximately half a million undocumented immigrants in the United States. However, Federal Judge Campbell Barker in Tyler, Texas, accepted a lawsuit filed by 16 Republican state attorneys general. These attorneys general accused the Biden administration of circumventing Congressional jurisdiction and implementing the measure for political purposes.

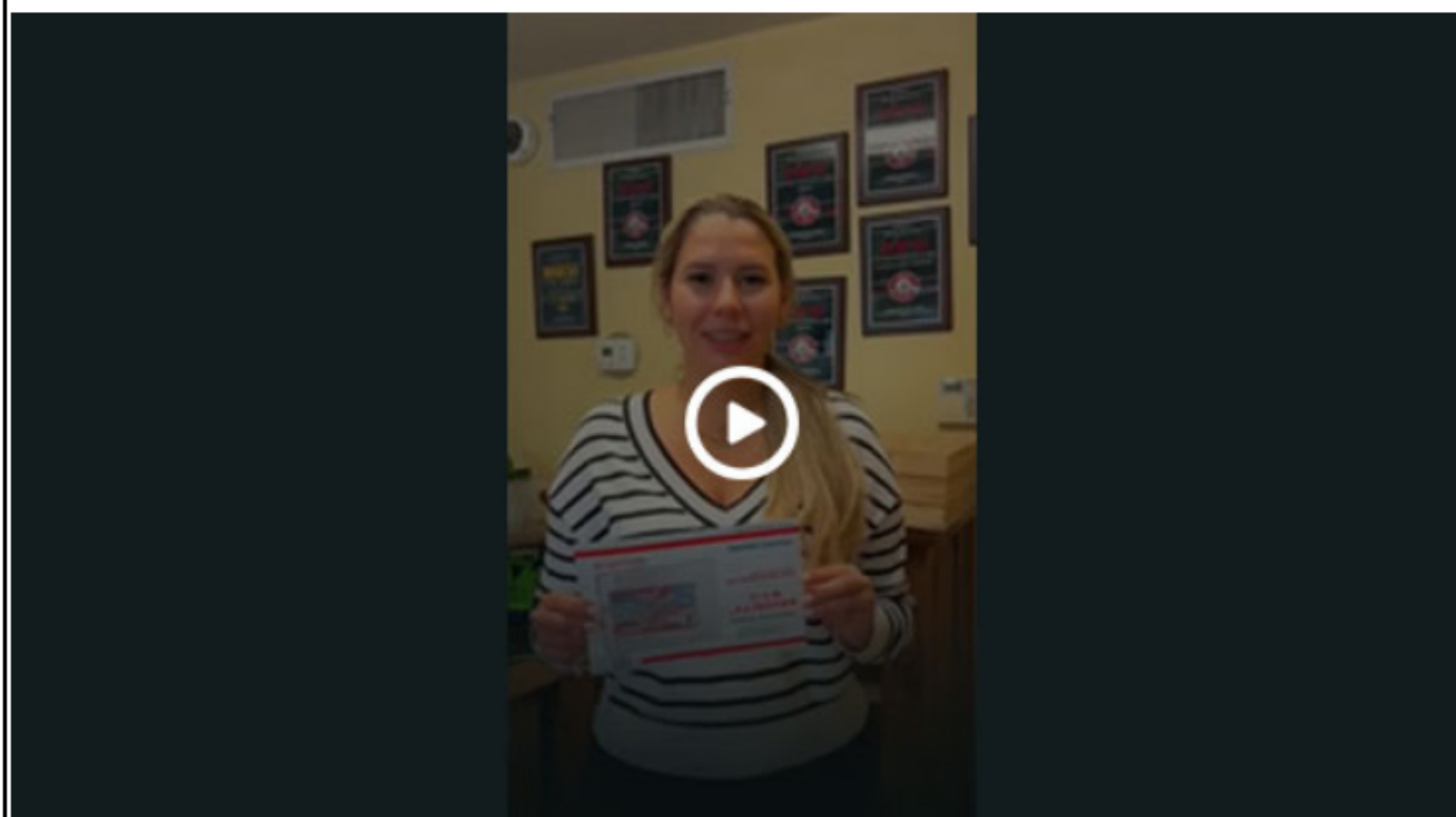
